1 The Series will be run under the Racing Rules of Sailing with RYA prescriptions and Class Association rules, except as stated in the sailing instructions.

2 All entrants must sign a declaration that they have valid third party insurance for a minimum of £3,000,000 and a valid class certificate.

3 All boats must have adequate buoyancy and personal buoyancy must be of an approved design and worn at all times when afloat, amending RRS 40. All competitors shall wear either a full wetsuit or drysuit at all times when afloat.

4 The safety of a boat and her entire management shall be the sole responsibility of the owner/competitor racing the boat, who must ensure that the boat and crew are adequate to face the conditions that may arise during the course of the race. Neither the sailing instructions nor the inspection of the boat under these conditions in any way limits or reduces the absolute responsibility of the owner/competitor for the crew, the boat and the management thereof. The race organisers shall not be responsible for any loss, damage, death or personal injury, howsoever caused, to the owner/competitor, the skipper or crew, as a result of their taking part in the race or races. Moreover every owner/competitor is absolutely responsible for the suitability of the boat for the race or races.

5 All participants are Guests of West Kirby Sailing Club / Dee Sailing Club for the duration of the Series, and will be required to sign the Visitors Book and be bound by Club rules. Attention is drawn to WKSC Rule 47 (Limitation of Liability of the Club), a copy of which is on display on the WKSC notice board.

In compliance with GDPR we will not use your personal details for any purpose other than organising this series.

Declaration

Helms and/or Crews who are under 18 on 22nd February 2020 must have a declaration form completed by their parent or guardian before they will be allowed to compete. The parental declaration form is part of the entry form.

I agree to be bound by the Racing Rules of Sailing, the rules of my Class Association, the Sailing Instructions and the liability disclaimer therein and all other rules that govern this Series.

Parent/Guardian Declaration

I confirm that the competitor is medically fit to take part in the event and any supporting activities on the above dates and I have listed overleaf any medical conditions that the organisers need to be aware of.

Disclaimer of Liability

Competitors or their parent/guardian - if below 18 years of age on 22nd February 2020, are entirely responsible for their own safety, whether afloat or ashore, and nothing reduces this responsibility. It is for them to decide whether their boat is fit to sail in the conditions in which it will find itself. By launching or going to sea, competitors or their parent/guardian confirm the boat is fit for those conditions and they are competent to sail and compete in them. Nothing done by the organisers can reduce the responsibility of the competitors or parents/guardians, nor will it make the organizers or their contractors responsible for any loss, damage, death or personal injury, however it may have occurred, as a result of the competitor taking part in the racing. The provision of patrol boats does not relieve competitors and their parents/guardians of their responsibilities. For the sake of clarity "the organisers" encompass everyone helping to run the event.
