Rules

Racing will be governed by The Racing Rules of Sailing 2017-2020 (RRS), the Regatta Sailing Instructions and the rules of the various Class Associations (except as any are changed by the Regatta Sailing Instructions).

Eligibility to Race

- a) All tidal classes, and dinghies with a recognised PN, are eligible to race.
- b) Adjusted PNs will be used for some classes. A list of changes from the RYA 2020 PNs will be available on the WKSC website and the Club Notice Board.
- c) The number of crew on a boat may be different from that required by their Class Association. However, as per Rule 4 of the RRS, sailing is at the competitors' risk and each person should carefully assess their capabilities and the capabilities of their crew in the conditions prevailing before launching

Protest Committee

Given the Covid 19 guidance from the RYA regarding social distancing any arbitration or protest hearings may be held by Zoom or Teams. If circumstances permit at the event, face to face hearings may be held outside or in a room dedicated for the purpose which has been disinfected and secured. Please note in any such hearings the boat models will be disinfected during the hearing and the jury may be limited to two people, which is permissible under RRS.

Risk Statement

Rule 4 of the Racing Rules of Sailing states:

"The responsibility for a boat's decision to participate in a race or to continue racing is hers alone." Sailing is by its nature an unpredictable sport and therefore involves an element of risk. By taking part in the event, each competitor agrees and acknowledges that:

- a) They are aware of the inherent element of risk involved in the sport and accept responsibility for the exposure of themselves, their crew and their boat to such inherent risk whilst taking part in the event;
- b) They are responsible for the safety of themselves, their crew, their boat and their other property whether afloat or ashore, and will carry adequate lifesaving equipment for all persons on board;
- c) They accept responsibility for any injury, damage or loss to the extent caused by their own actions or omissions;

- d) Their boat is in good order, equipped to sail in the event and they are fit to participate;
- e) The provision of a race management team, patrol boats and other officials and volunteers by the event organiser does not relieve them of their own responsibilities;
- f) The provision of patrol boat cover is limited to such assistance, particularly in extreme weather conditions, as can be practically provided in the circumstances;
- g) It is their responsibility to familiarise themselves with any risks specific to this venue or this event drawn to their attention in any rules and information produced for the venue or event and to attend any safety briefing held at the venue

COVID Statement

By taking part in any of the events covered by this Notice of Race, each competitor agrees and acknowledges that they are responsible for complying with any UK government guidelines and legislation in force at the time of this event in respect of COVID–19 and for complying with West Kirby Sailing Club COVID–19 procedures (www.wksc.org.uk).

Competitors participate in the event entirely at their own risk. The organising authority does not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during, or after the event.

By entering this event, competitors accept these conditions unconditionally.

Insurance

Each participating boat shall be insured with valid third-party liability insurance with a minimum cover of £3,000,000 per incident or the equivalent.
